DIRECTIONS FOR USE

Commercial Grade Surface Spray Disinfectant (1:10)

Dilute with 75ml of LEMON PROOF per 750ml of water.

Simply spray the entire surface and leave for 8 minutes. Wipe off excess using damp sponge or cloth.

Spray & Wipe Cleaning/Sanitation:

Light Duty - 7.5ml LEMON PROOF per 750ml bottle, fill with water.

Medium Duty - 13ml LEMON PROOF per 750ml bottle, fill with water.

Heavy Duty - 20ml LEMON PROOF per 750ml bottle, fill with water.

Simply spray and wipe off immediately using damp sponge or cloth.

Mopping - Dilute 150ml LEMON PROOF into 10L of HOT water, damp mop floor, and leave to dry.
